His responsibilities have included ordnance handling, preparation, inspection, and shipment, directly supporting our government clients with precision and dedication.

Work Ethic & Professionalism

Mr. Carey has proven to be a self-starter who regularly takes the initiative to verify ordnance status, prepare facilities, and execute logistical tasks—often without direct supervision. He consistently exhibits a strong attention to detail and an unwavering commitment to safety, accuracy, and mission readiness.

Technical Proficiency

Facility Management

In his capacity as a facility manager, Mr. Carey played a key role in restructuring warehouse operations to separate reportable and non-reportable assets by project. This initiative significantly enhanced operational efficiency and audit readiness. He also designed and installed an Ordnance Handling Equipment (OHE) storage wall, which improved site safety and organization at Building 134A.

Mr. Carey ensured that multiple facilities—including Buildings 618, 492, and 134A—were properly prepared for government inspections, classified walkthroughs, and high-level visits, further demonstrating his attention to operational readiness.

Customer-Focused Support
